



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, THE PROVINCIAL ADMINISTRATOR'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0809; re; Procurement of Various Office Supplies, by the Provincial Administrator's Office, New Capitol Site, Tagbilaran City, Bohol, with an ABC of P69,872.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;

- b.) To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING for the delivery of goods/services under Negotiated Canvass No. 2021-0544 in the amount of P 69,852.40;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
