



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the OFFICE OF THE VICE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0867; re; Procurement of Various Spare Parts for the Repair & Replacement of Defective Parts of Aircon System for Mitsubishi Strada with Plate No. SKY 326, by the Office of the Vice Governor, New Capitol Compound, Tagbilaran City.. with an ABC of P 74,340.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


