BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 21- 1499 Series of 2021

WHEREAS, the OFFICE OF THE VICE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0867; re; Procurement of Various Spare Parts for the Repair & Replacement of Defective Parts of Aircon System for Mitsubishi Strada with Plate No. SKY 326, by the Office of the Vice Governor, New Capitol Compound, Tagbilaran City... with an ABC of P 74,340.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>TAGBILARAN CITY TYRE SALES & SERVICE CENTER</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;
