BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0880 re: Procurement of Electrical Supply for PGBh Facilities/Activities including Old Airport in Support to Covid-19, by the Office of the Governor, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol with an ABC of P 1,199,922.90;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CLAIRE CONSTRUCTION AND SUPPLY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of CLAIRE CONSTRUCTION AND SUPPLY including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, CLAIRE CONSTRUCTION AND SUPPLY has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare CLAIRE CONSTRUCTION AND SUPPLY as the bidder with the **SINGLE CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 21-0645;
- b.) To recommend award to CLAIRE CONSTRUCTION AND SUPPLY for the delivery of goods under Negotiated Canvass No. 21-0645 in the amount of P 1,199,410.50
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
