

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0884; re; Procurement of Various Vehicle Spare Parts for the Repair & Maintenance/Use of Ambulances & service Vehicles of PDRRMO, by the Provincial Disaster Risk Reduction & Management Office, Camp Bernido Compound, Dao District, Tagbilaran City, with an ABC of P 349,318.50;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
