BAC Resolution Declaring LCRQ and Recommending Award

RESOLUTION NO. <u>41-</u>228 Series of 2021

WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL made procurement under</u> Purchase Request No. 2021-C-126 re: <u>PROVISION OF MEALS & ACCOMMODATION DURING PHO DISEASE CONTROL PROGRAM VARIOUS ACTIVITIES</u> with an ABC of ₱ 367,550.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>REYNA'S THE HAVEN & GARDENS FOOD CATERING SERVICES</u>, <u>INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

- b). To recommend award to <u>REYNA'S THE HAVEN & GARDENS FOOD CATERING SERVICES</u>, INC. for the Catering & Accommodation Services of the aforementioned request in the amount of <u>P 354, 610.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
