THIS AGREEMENT, made this 3rd day of DECEMBER, 2021 between PROVINCIAL TREASURER'S OFFICE of the Provincial Government of Bohol (hereinafter called the "Entity") and BELLE SOUTH PACIFIC PROPERTIES, INC./ THE BELLEVUE RESORT of Doljo, Panglao, Bohol (hereinafter called the "the Supplier").
