WHEREAS, the GARCIA MEMORIAL PROVINCIAL HOSPITAL, TALIBON, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 044 re: PROCUREMENT OF VARIOUS HARDWARE SUPPLIES AND CONSTRUCTION MATERIALS FOR GMPH REPAIR AND MAINTENANCE OF BUILDINGS AND OTHER STRUCTURE with an ABC of P 190,062.00;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BQ BUILDERWARE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid BQ BUILDERWARE has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a.) To declare BQ BUILDERWARE as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 116,177.00 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2021 - 022; except for items no. 3, 15, 18, & 19 recommended for re-canvass;
- b.) To recommend award to BQ BUILDERWARE in the amount of ONE HUNDRED SIXTEEN THOUSAND ONE HUNDRED SEVENTY SEVEN PESOS ONLY (P 116,177.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 022;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
