WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-1146 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2021-0098 re: Procurement for Renovation and Improvement of Staging House at Bohol Bio Diversity Complex, Bilar, Bohol by the Provincial Economic Enterprise Management Office, New Capitol Building, Tagbilaran City. with an ABC of ₱ 499,127.47;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that C. JANSEN CONSTRUCTION AND GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;


