WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. _____ series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2021-0347 re: Procurement of Desktop Computer & Printer 3-in-1, by the Office of the Provincial Agriculturist, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol, with an ABC of ₱ 631,400.00


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC., offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

- b). To recommend award to B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC. or delivery of goods/services under Negotiated Canvass No. 2021-0278 (2nd Failure) in the amount of ₱ 626,304.00;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




