WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-123 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode, and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL EMPLOYMENT & PLACEMENT OFFICE in undertaking Procurement Request under PR No. 2021-0783/re: Procurement of Various Computer Desktops by the Bohol Employment & Placement Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol, with an ABC of ₱ 99,905.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SANDUGO PRESS MARKETING AND SUPPLIES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
