WHEREAS, the PROVINCIAL HUMAN RESOURCE MANAGEMENT AND DEVELOPMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-173 re: PROVISION OF CATERING SERVICES DURING THE COMPETENCY FORMULATION, ASSESSMENT AND PROFILING with an ABC of P 266, 000.00:

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>REYNA'S THE HAVEN</u>
