WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-172 series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode, and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GENERAL SERVICES OFFICE in undertaking Procurement Request under PR No. 2021-0695 re: Procurement of Oil Filter, Fuel Filter, 2T Oil, Engine Oil Diesel for the Maintenance of Generators, by the Provincial General Services Office, Bohol Provincial Capitol Building, Cocon District, Tagbilaran City, with an ABC of ₱ 61,250.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 200 M AUTO REPAIR SHOP & PARTS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;


WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, 200 M AUTO REPAIR SHOP & PARTS has been found to be ELIGIBLE and its quotation, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:


- a). To declare 200 M AUTO REPAIR SHOP & PARTS as the supplier with the Lowest Calculated and Responsive Price Quotation for the Delivery of Goods/Services under Negotiated Canvass No. 2021-0598 (2<sup>ND</sup> Failure);
- b). To recommend award to 200 M AUTO REPAIR SHOP & PARTS or delivery of goods/services under Negotiated Canvass No. 2021-0598 (2<sup>nd</sup> Failure) in the amount of ₱ 61,194.00;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.


