


BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-162 re: PROVISION OF ROOM ACCOMMODATION & MEALS FOR THE VISITING DIGNITARIES, VIPS & GUEST DURING THE OFFICIAL VISIT & CONSULTATIVE MEETING with an ABC of ₱ 300,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>THE BELLEVUE</u> <u>RESORT</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>THE BELLEVUE RESORT</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>THE BELLEVUE RESORT</u> has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED:

- a). To declare <u>THE BELLEVUE RESORT</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE</u> <u>QUOTATION</u> for the <u>CATERING & ACCOMMODATION SERVICES</u> under Negotiated Canvass No. 21-131;
- b). To recommend award to <u>THE BELLEVUE RESORT</u> for the Catering & Accommodation Services of the aforementioned request in the amount of <u>P 300,000.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
