WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-201 re: PROVISION OF MEALS & ACCOMMODATION FOR PGBH-CSO CORE GROUP & TECHNICAL WORKING GROUP ASSESSMENT & PLANNING FOR 2022 PROGRAMS ACTIVITIES with an ABC of ₱ 147,000.00;
