


BAC Resolution Declaring LCRQ and Recommending Name

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL Purchase Request No. 2021-C-201 re: PROVISION OF MEALS & ACCOMMODATION FOR PGBH-CSO COME GROUP ASSESSMENT & PLANNING FOR 2022 PROGRAMS ACTIVITIES with an ASC of ₱ 147,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>THE BELLEVUE</u> <u>RESORT/ BELLE SOUTH PACIFIC PROPERTIES, INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of THE BELLEVUE RESORT/BELLESOUTH PACIFIC PROPERTIES, INC. including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, THE BELLEVUE RESORT/BELLE SOUTH PACIFIC PROPERTIES, INC. has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED:

- a). To declare THE BELLEVUE RESORT/ BELLE SOUTH PACIFIC PROPERTIES, INC. as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the CATERING & ACCOMMODATION SERVICES under Negotiated Canvass No.21-174;
- b). To recommend award to <u>THE BELLEVUE RESORT PANGLAO</u> for the Catering & Accommodation Services of the aforementioned request in the amount of <u>P147,000.00</u>;
