

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare BQ BUILDERWARE as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION in the amount P 51,648.00 for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2021 - 180; except for items no. 4 & 7 recommended for re-canvass;
- b.) To recommend award to BQ BUILDERWARE in the amount of FIFTY ONE THOUSAND SIX HUNDRED FORTY EIGHT (P 51,648.00) for the delivery of goods under Negotiated Canvass No. - PHO - 2021 - 180;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
