WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0373-A series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by THE GO - PROVINCIAL INFORMATION & MEDIA RELATIONS in undertaking Procurement Request under PR No. 2021-0373 re; Procurement for the Rental of Online Telecast Live Broadcasting Equipment for Daily Live Press Conference of Covid - 19 Monitoring & Provincial Government Program Update, by the GO - Provincial Information & Media Relations, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ABC of ₱ 540,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 136 ACTIVE EVENTS EQUIPMENT RENTALS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




