

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0722; re; Procurement of Engine Oil, Tires & Various Vehicle Spare Parts with Labor for the Repair & Maintenance of the Ambulance & Service Vehicles, by the Provincial Disaster Risk Reduction & Management Office, Camp Bernido Compound, Dao District, Tagbilaran City, with an ABC of P 385,890.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;




