

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0836; re; Procurement of Vehicle Repair, Maintenance with Replacement of Various Vehicle Spare Parts for the Service Vehicle, by the Provincial Disaster Risk Reduction & Management Office, Camp Bernido Compound, Dao District, Tagbilaran City, with an ABC of P 281,940.00.


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of TAGBILARAN CITY TYRE SALES & SERVICE CENTER including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid TAGBILARAN CITY TYRE SALES & SERVICE CENTER has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare TAGBILARAN CITY TYRE SALES & SERVICE CENTER as the bidder with the **LOWEST CALCULATED AND RESPONSIVE BID** for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2021-0571;
- b.) To recommend award to TAGBILARAN CITY TYRE SALES & SERVICE CENTER for the delivery of goods/services under Negotiated Canvass No. 2021-0571 in the amount of P 281,671.00;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.




