WHEREAS, THE BOHOL DISTRICT JAIL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0859; re: Procurement of Various Office Supplies, by the Bohol District Jail, Cabawan District, Tagbilaran City. with an ABC of P 207,201.00;






