



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Contrillor and Recommending Approval

WHEREAS, THE BOHOL DISTRICT JAIL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0859; re; Procurement of Various Office Supplies, by the Bohol District Jail, Cabawan District, Tagbilaran City. with an ABC of P 207,201.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <a href="PRIM E CONSTRUCTION SUPPLIES">PRIM E CONSTRUCTION SUPPLIES</a>
TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;
