

## **BAC Resolution Declaring LCRQ and Recommending Award**

WHEREAS, the PROVINCIAL TREASURER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-166 re: PROVISION OF CATERING SERVICES FOR MEALS & SNACKS INCLUDING 1 CONDUCT OF ACCOMMODATION DURING THE DAY YEAR-FNO 1 ORIENTATION/DISCUSSION ON THE REVISED SPMS IRR with an ABC of ₱ 186,300.00;
