WHEREAS, the PROVINCIAL TREASURER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-166 re: PROVISION OF CATERING SERVICES FOR MEALS & SNACKS INCLUDING 1 NIGHT ACCOMMODATION DURING THE CONDUCT OF 1 DAY YEAR-END ASSESSMENT AND ORIENTATION/DISCUSSION ON THE REVISED SPMS IRR with an ABC of ₱ 186,300.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BELLE SOUTH PACIFIC PROPERTIES, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
