WHEREAS, the PROVINCIAL HEALTH OFFICE- BPIC of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2021-C-192 re: PROVISION OF MEALS & SNACKS FOR THE CONDUCT OF INFECTION CONTROL UPDATES, BASIC LIFE SUPPORT AND ADVANCE CARDIAC LIFE SUPPORT with an ABC of ₱ 59,375.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:
