

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL PLANNING AND DEVELOPMENT OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2021-0831</u>; re; <u>Procurement of Vehicle Rental for Monitoring, Evaluation & Site Inspection of Small livelihood Projects & Regular Sub Projects, by the Provincial Planning and Development Office, Bohol Provincial Capitol Building, Cogon <u>District, Tagbilaran City.</u> with an ABC <u>P 69,500.00.</u></u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL TOURIST MULTI-PURPOSE</u> <u>COOPERATIVE</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
