WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 267 re: PROCUREMENT OF VARIOUS I.T EQUIPMENT with an ABC of P 199,725.00.


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B&J COMPUTER SALES AND ELECTRONIC SERVICES INC., offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




