



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GOVERNOR'S OFFICE-BOHOL INFORMATION AND COMMUNICATION TECHNOLOGY OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0598; re; Procurement of IT Equipment, by the Governor's Office-Bohol Information and Communication Technology Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 260,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
