

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Dec Quotation and Recommending Approval

RESOLUTION NO. 21-1324 Series of 2021

WHEREAS, THE OFFICE OF THE SP-BOARD MEMBER CHRISTIAN VICTOR S. BOLOS III, of the PROVINCIAL GOVERNMENT OF BOOD made procurement of goods under Purchase Request No. 2021-0680; re; Procurement of Various Janitorial & Office Supplies, by the Office of the Board Member Christian Victor S. Bolos III, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol. with an ASC of P 62,799.41;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PARK AVENUE GENERAL MERCHANDISE offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;
