


WHEREAS, pursuant to Resolution No. 04 – 2006 of GPPB and under Sec. 53.9 of R.A. 9184 upon careful examination, validation and verification of the price quotation offered **B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC. AND GOLDEN AI TRADING** have been found to be **ELIGIBLE** and its bid, **RESPONSIVE**, thus Split Award shall be taken into consideration;

NOW, THEREFORE, We, the Members of the Bids and Award Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a.) To declare **B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.** for item # **2,3,4,6,8 & 9** in amount of **P 233,048.00**, to **GOLDEN AI TRADING** and for item **1 & 5** in amount of **P 70,490.00**, as the suppliers with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION**, while item no. **7** is above ABC and therefore recommend for cancellation for the request under Negotiated Canvass No. **2021-0515** for the Procurement of Various IT Equipment, by the Office of the Governor, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City;
- b.) To recommend award to **B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.** for item # **2,3,4,6,8 & 9** in amount of **P 233,048.00**, to **GOLDEN AI TRADING** and for item **1 & 5** in amount of **P 70,490.00** while item no. **7** is for cancellation for the Procurement of Various IT Equipment, by the Office of the Governor, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.






