BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 2021 - SIS Series of 2021

WHEREAS, the <u>TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2021 - 321</u> re: <u>PROCUREMENT FOR SUPPLY & INSTALLATION OF THE RECONNECTION OF A 3 PHASE, 3 WIRE NEW POWER SOURCE/SUPPLY (3 - 50KVA DISTRIBUTION POWER TRANSFORMER)</u> with an ABC of <u>P 346,462.19.</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>B&J</u> <u>COMPUTER SALES AND ELECTRONIC SERVICES, INC.</u>, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of B&J COMPUTER SALES AND ELECTRONIC SERVICES, INC. including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid B&J COMPUTER SALES AND ELECTRONIC SERVICES, INC., has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to <u>B&J COMPUTER SALES AND ELECTRONIC SERVICES, INC.</u>, for the delivery of goods under <u>Negotiated Canvass No. PHO 2021 248</u>, in the amount of <u>THREE HUNDRED FORTY FIVE THOUSAND EIGHT HUNDRED PESOS ONLY <u>P 345,800.00</u>;</u>
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
