**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

**WHEREAS, the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2021 - 321 re: PROCUREMENT FOR SUPPLY & INSTALLATION OF THE RECONNECTION OF A 3 PHASE, 3 WIRE NEW POWER SOURCE/SUPPLY ( 3 - 50KVA DISTRIBUTION POWER TRANSFORMER) with an ABC of P 346,462.19.**


**WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B&J COMPUTER SALES AND ELECTRONIC SERVICES, INC., offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,**

**WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of B&J COMPUTER SALES AND ELECTRONIC SERVICES, INC. including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid B&J COMPUTER SALES AND ELECTRONIC SERVICES, INC., has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;**


**NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:**

- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




