

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:



- To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings




