

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value. Declaring Lower Declared Procurement and Recommending Approval

RESOLUTION NO. <u>21-1498</u> Series of 2021

WHEREAS, THE OFFICE OF THE GOVERNOR - SPS; of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0439; re; Procurement of Various Office Supplies, by the Office of the Governor - SPS, Bohol Provincial Capital Building, Cogon District, Tagbilaran City. with an ABC of P. 73,600.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **GOLDEN AI TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of bid Quotations;

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
