WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-0357 Series of 2021 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode, and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL ENVIRONMENT MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2021-0443, re: Procurement of Supply & Installation of Fixed Glass with Aluminum Framing & Swing Glass Door, by the Bohol Environment Management Office, Bohol Provincial Capitol Building, Cooon District, Tagbilaran City, Bohol, with an ABC of ₱ 62,516.46;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that A&D CONSTRUCTION AND SUPPLY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;



- b). To recommend award to A&D CONSTRUCTION AND SUPPLY or delivery of goods/services under Negotiated Canvass No. 2021-0357 (2nd Failure) in the amount of ₱ 62,062.50;
- c). To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


