WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2021-0620 (Series of 2021) on BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Method duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL DISTRICT JAIL FACILITIES AT BOHOL DISTRICT JAIL in undertaking Procurement Request under PR No. 2021-0620 re: Procurement of Repair & Renovation of Bohol District Jail Facilities at Bohol District Jail - Main Dormitory, by the Bohol District Jail, Cabawan District, Tagbilaran City, Bohol, with an ABC of P 527,225.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3N CONSTRUCTION & SUPPLY, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;




