WHEREAS, in the detailed evaluation of bids, **AGRIMACH CG CORPORATION** was declared as the Lowest Calculated Bid as Read for **item nos. 1 & 5-8** while **SUKI TRADING CORPORATION** was declared as the Lowest Calculated Bid as Read for **item nos. 2, 3 & 9** while item no. 4 is subject for rebidding;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **AGRIMACH CG CORPORATION AND SUKI TRADING CORPORATION** met the required legal, technical and financial requirements for the said project;


WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **AGRIMACH CG CORPORATION AND SUKI TRADING CORPORATION**, the bidders declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST COMPLYING and RESPONSIVE BID** for the said project;


NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:




