WHEREAS, in the detailed evaluation of bids UBAY MACHINERIES & PARTS SUPPLY & FABRICATION WELDING SHOP was declared as the Lowest Calculated Bid as Read and was recommended for post qualification;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, UBAY MACHINERIES & PARTS SUPPLY & FABRICATION WELDING SHOP was recommended for disqualification due to the reasons; 1.) Inconsistencies in the SLCC Information, 2.) Wrong NFCC Computation and 3.) No Marginal Signatures in every Page;

WHEREAS, in the detailed evaluation of bids AGRIMACH CG CORPORATION as the Second Lowest Calculated Bid as Read was recommended for post qualification process;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, AGRIMACH CG CORPORATION met the required legal, technical and financial requirements for the said project
