

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **REGIONAL TRIAL COURT - BRANCH 3** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2021-0826**; re; **Procurement of I.T Equipment, by the Regional Trial Court - Branch 3, Hall of Justice, Tagbilaran City, Bohol.** with an ABC of **P 55,400.00.**






