BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 22 -001 Series of 2022

WHEREAS, the GO - PROVINCIAL INFORMATION & MEDIA RELATION of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0251, re; Procurement of Ink for High Speed Inkjet Printer, by the GO - Provincial Information & Media Relation, New Capitol Compound, Tagbilaran City. with an ABC of P 376,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>COPYLANDIA OFFICE</u> <u>SYSTEMS CORPORATION</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
