WHEREAS, the **GO - PROVINCIAL INFORMATION & MEDIA RELATION**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0251; re; Procurement of Ink for High Speed Inkjet Printer, by the GO - Provincial Information & Media Relation, New Capitol Compound, Tagbilaran City. with an ABC of P 376,000.00;


