WHEREAS, the OFFICE OF THE VICE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0061; re; Procurement of S20 Multicopy Paper for use at the Office of the Vice Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 943,596.00;
