WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. _____ series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the TEODORO B. GALAGAR DISTRICT HOSPITAL, JAGNA, BOHOL in undertaking Procurement Request under PR No. - PHO - 2021 - 216 re: PROCUREMENT OF HOUSEKEEPING/JANITORIAL SUPPLIES with an ABC of P 477,540.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PARK AVENUE GENERAL MERCHANDISE offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, PARK AVENUE GENERAL MERCHANDISE has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- To declare PARK AVENUE GENERAL MERCHANDISE as the supplier with the Lowest and Responsive Price Quotation in the amount of P 475,105.30; for the Delivery of Goods under Negotiated Canvass No. - PHO - 2021 - 217 (2nd failure of bidding);
- To recommend award PARK AVENUE GENERAL MERCHANDISE in the amount of FOUR HUNDRED SEVENTY FIVE THOUSAND ONE HUNDRED FIVE PESOS AND 30/100 (P 475,105.30) for the Delivery of Goods under Negotiated Canvass No. - PHO - 2021 - 217 (2nd failure of bidding);
- To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
