WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-1168 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE in undertaking Procurement Request under PR No. 2021-0732 re; Procurement of Document Photographic Scanner, Printer, Internet Router, Trolley, Push Cart & Air Conditioning Unit, by the Provincial Economic Enterprise Management Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City. with an ABC of ₱ 100,000.00;


