BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, TAGBILARAN CITY</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2021 - 422</u> re: <u>PROCUREMENT OF MEDICAL SUPPLIES</u> with an ABC of <u>P 401,259.00.</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY, offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY, has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY</u>, as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. PHO 2021 331;
- b.) To recommend award to <u>INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY</u>, for the delivery of goods under <u>Negotiated Canvass No. PHO 2021 331</u>, in the amount of **FOUR HUNDRED** THOUSAND TWO HUNDRED FIFTY SEVEN PESOS AND 50/100 <u>P 400,257.50</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
