WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 21-1170 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **OFFICE OF THE GOVERNOR - CD - ART** in undertaking Procurement Request under PR No. 2021-0769 re: Procurement of Office Supplies & Materials for the Training of CAFGU Active Auxiliary II (CAAll) in the Province, by the Office of the Governor - CD - ART, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of ₱ 72,720.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **5 ANGELS TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, **5 ANGELS TRADING** has been found to be ELIGIBLE and its quotation, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




