WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 2-12 series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE GOVERNOR CD - ART in undertaking Procurement Request under PR No. 2021-0769 re; Procurement of Office Supplies & Materials for the Training of CAFGU Active Auxiliary IV (CAAII) in the Province, by the Office of the Governor - CD - ART, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of P72,720.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>5 ANGELS</u> <u>TRADING</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
