

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **OFFICE OF THE SP-BOARD MEMBER RESTITUTO B. AUXTERO**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0887 re; **Procurement of Tubeless Tire, Engine Oil, Oil Filter & Tire Rod Set End for SKY 346, by the Office of the SP - Board Member Restituto B. Auxtero, New Capitol Compound, Tagbilaran City, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City, Bohol.** with an ABC of P 67,090.00;
