



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

WHEREAS, the PROVINCIAL ENGINEER'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0907; re; Procurement of Various Hardware Supplies for the Emergency Repair of Cansiwang Bridge at Cabantian-Cansiwang-Mayuga Road, Guindulman, Bohol, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 292,460.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3N CONSTRUCTION & SUPPLY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
