BAC Resolution Recommending the Use of Negotiated Procurement through Emergency Cases, Declaring Single Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL GENERAL SERVICES OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2021-0926 re: Procurement of Electric Breaker for the Generator at Bohol Cultural Center, by the Provincial General Services Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of P 192,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that NODAL ELECTRIC TRADE & SERVICES offered the single price quotation among the suppliers as reflected in the Abstract of Bid Quotations,
